Contract Negotiations

The 2019-2023 National Agreement between NALC and USPS expired at midnight on May 20, 2023. The parties opened negotiations for the 2023 National Agreement on February 22, 2023. Although an agreement has not been reached by the May 20 deadline, the parties continue to negotiate during the mandatory 60 day mediation time frame. NALC will continue to work towards a negotiated agreement with the Postal Service during that 60 day period. If an agreement is reached, it will be presented to the membership for a vote. If an agreement is not reached, issues that remain in dispute will be addressed through an interest arbitration process, which would result in a final and binding decision on the contents of a new national agreement. The parties would select a neutral arbitrator to chair an arbitration board which would include one management and one union arbitrator.

NALC has made it clear that city letter carriers need to be recognized and rewarded for their hard work, long hours, and exceptional performance during the COVID pandemic and the most recent two national elections. Our members delivered essential goods to America's people during the pandemic, at great risk to themselves and their families. They did their part to preserve our democracy by protecting and expanding our nation's vote by mail option. Their work cannot go unrewarded.

NALC has also insited that the issue of staffing must be addressed in our next contract. Improved and competitive wages will help to address the staffing shortage, but a fully career workforce is the cornerstone of a stable future for our craft and the Postal Service. Providing fair starting wages, full benefits, and a regular schedule is the only way to attract and retain the people we need to continue to provide the service the American people deserve. NALC has made this issue a priority in negotiations, and the Postal Service must be aware of its importance going forward.

The safety of letter carriers and the increasing crime against those carriers is no less of a priority. USPS and NALC must work together to address this critical issue. Letter carriers should not have to fear for their lives or their safety when reporting to work. Solutions to this growing crisis have to be found and found as quickly as possible.

NALC has committed to address management's failure to adhere to the terms of the jointly negotiated national agreement and the provisions of their own handbooks and manuals. Repetitive violations and non-compliance with negotiated grievance settlements and decisions has eroded an already contentious relationship between the union and management at all levels of the Postal Service. Managers who engage in this unacceptable behavior must be held accountable.

I am encouraged by NALC's stated priorities in their attempt to reach agreement on a new national agreement. It is my hope that the USPS representatives realize that their priorities should mirror ours if their goal is a vibrant and thriving Postal Service, now and into the future. Without fair wages and benefits a stable workforce is not attainable. Letter carriers must also be treated with dignity and respect, and that cannot be accomplished if management is permitted to ignore their obligation to honor written agreements. A prosperous future for the Postal Serivce is dependant upon achieving all of these goals.

I would also like to take this opportunity to congratulate the winners of the four NJ Merged Branch 38 scholarships. These four young women performed greatly throughout their high school careers, both in the classroom and in their communities. I know that their parents are proud of their achievements, and we join them in wishing them well throughout their college years and beyond. It is our pleasure to recognize their achievements and to provide some small assistance as they persue their goals.

LiteBlue & eOPF Problems

In late December, several hundred employees mistakenly used fraudulent websites to sign-on to LiteBlue and their accounts. As a result, their net-to-bank allotments were hacked and changed. After the Postal Service learned of the scam, all net-to-bank information was removed. The eOPF files and direct deposit options were disabled. It has been six months since the fraudulent websites occurred and numerous employees are still experiencing LiteBlue and eOPF sign-on issues.

To increase the security of LiteBlue, the Postal Service implemented multifactor authentication (MFA) necessary to gain access when signing on. In January, all employees were instructed to sign-in to LiteBlue and set up the multifactor authentication. If you did not, a letter was sent to your address of record with the Postal Service with a new password to set up the MFA. Many employees still have not set up MFA or have set up MFA only to be locked out again.

If you are still experiencing issues signing on to LiteBlue, you have options. The easiest remedy is to sign onto LiteBlue again and request a password reset. Again, a letter will be sent to your address of record with the Postal Service, which could take seven to ten business days. If that option has not worked and you are still waiting for a letter or your address is not correct, you can use the US Postal Employee Service Line.

The US Postal Employee Service Line will connect you to an automated listing of prompts. Many employees may be familiar with the phone number, 1-877-477-3273. The service line is used to access Postalease, Job Bidding, Unscheduled Leave, and HR Shared Services. When selecting the HR Shared Services option five, you will be able to select Employee Benefits, Retirement, Family Medical Leave Act, EHRSSC forms, and other options. The Employee Benefits option will allow you to access information regarding health and life insurance, Thrift Savings Plan, Military and Civilian Leave Buyback, Self-Service Password profile, pin resets, salary or pay inquires, etc. You will need to have your

Employee Identification Number (EIN) and your pin number available when prompted to enter on the touchtone pad. The wait time when calling the US Postal Service Line can be lengthy. Please allow yourself enough time when placing the call.

The eOPF, Official Personnel File, continues to be unaccessible through LiteBlue and could be unavailable for another four months. If you are retiring or need access to your Official Personnel File (OPF), all employees can request a copy of your file either in-person or in writing with the District Manager of Human Resources. If make your request in writing, you will need to prove your identity. To our contact New Jersey District Manager of Human Resources, Jaya R. Bhambhwani, you can call, email, or visit the district office. The phone number is (732) 819-3614. The email address is Jaya.r.bhambhwani@usp.gov. The district office is located at 21 Kilmer Road, Edison, NJ 08899-9998. While the eOPF through LiteBlue is unavailable, there will be no fee for your personnel file.

Hopefully, the above options will help employees who are still unable to access LiteBlue and eOPF. In the future, I strongly suggest you sign onto the legitimate LiteBlue site, by typing the web address www.liteblue.usps.gov directly in the URL bar at the top of the page and never use any search engine. Prior to entering any of your personal information, check to make sure you are on the correct website. These steps can protect your personal information when accessing LiteBlue.

The Elks is @1/2 mile down the road on your left.
